This collection of legal documents and papers originated in the Eureka County, Nevada, District Attorney's Office, and was acquired by the Nevada Historical Society from the Nevada State Library and Archives. Included are items, chiefly dating from 1946-1950, from the private law practice and the work as Eureka County District Attorney, of John F. Sexton. There is correspondence with clients, collection letters, political papers, deeds, divorce cases, probate cases, guardianship, and leases.
