HOWARD WILLIAM SQUIRES 1909-1969

Howard William Squires, Jr. was born on June 8, 1909, in Long Beach, California, to Mary Elizabeth Gilmore and Howard William Squires, Sr. He later moved to Nevada and attended the University of Nevada, graduating in 1933 with a degree in Civil Engineering. Squires married Grace Lenore Evans in Carson City, Nevada on June 9, 1934 when he was 25 years old. They later settled in Virginia City, Nevada. The marriage produced two children, a girl, Jeanne (b.1942) and boy, Richard (b.1947). Mr. Squires was involved in the mining business during much of the 1930s, which included establishing two companies, the Adriatic Mines, Inc. and the Great Southwest Mines Development Company with his partner, Jess R. Midgely. They were active in several mining operations on the Comstock and elsewhere. Both companies were headquartered in Virginia City. He was also appointed Storey County surveyor in 1942. These activities were interrupted by World War II where Squires served in the Navy as a lieutenant and saw combat duty in the South Pacific. He was honorably discharged in 1945.

In 1946, Howard Squires was the Republican candidate for State Assembly from Storey County, but lost to Mervin J. Gallagher. He was appointed Director of the Nevada Park Commission in 1954 and was named the first Nevada State Park Director, serving from 1955-1959. In 1957, the Squires' built a new residence in Carson City at 621 Mary Street. Throughout the 1950s, Squires was active in the American Legion, Masons, and the Boy Scouts of America. During the 1960s, he was employed by the Nevada Highway Commission and retired in June 1969 from the civil engineering department of Ormsby County.

Howard William Squires, Jr. died on October 7, 1969 in Virginia City, Nevada, at the age of 60, and was buried there. His wife Grace passed away on October 13, 1972 in Carson City.

SCOPE AND CONTENT OF THE COLLECTION

The papers of Howard William Squires consist primarily of an assortment of business receipts and invoices which document routine purchases and expenses he and his family incurred during his life in California, Nevada and while in military service. Only representative samples of these documents are retained in this collection. There is little personal correspondence, except some concerning his invention of a "dynamic reactor" device, mining business issues during the 1930s and '40s, his employment with the Nevada State Park Commission and his service as Director of Parks for the state of Nevada.

The financial records are mostly composed of checkbooks, expense records, the family's new home construction in Carson City, medical bills, court records, loans and various other transactions. There are three slim folders of photographs which include snapshots of various mining operations, Nevada State Parks photos and several of a model of an invention Squires was working on. Included are two 8 x 10" group pictures of park officials with Governor Charles Russell. There are numerous books and other publications regarding technical engineering and mining processes as well as a book on mining laws in the Western States.

Mr. Squires was active in the American Legion and kept records from annual conventions of that organization from 1949 through 1960 which are included in the collection. The remaining files consist of a folder on the Boy Scouts of America, news clippings, insurance and legal documents, miscellaneous printed materials, and professional membership cards.
